## ORDER

During the hearing on 06.10.2016, the Learned Counsels for the respondents submitted that the copies of the Annexures stated in the I.A.No.18 of 2016 filed in the instant petition have not been supplied along with the I.A. The Learned Counsel for the petitioner supplied the copies of the annexures to the counsels for the respondents during the hearing. The Learned Counsel for the petitioner prayed for an adjournment for a longer date. The Commission acceded to the prayer and fixed the next date for hearing on 29.11.2016.

Respondent No.1 PSPCL filed a short reply in the I.A. for amendment filed by the petitioner vide CE/ARR&TR, PSPCL Patiala Memo No.6315/TR-5/772 dated 25.10.2016.

During the hearing, the Learned Counsel for the petitioner submitted that the petitioner shall withdraw the instant I.A. with a prayer for liberty to file a new/amended I.A. on the ground that the plant of the petitioner is ready. However, the Grid is not ready as civil works are still going on. The petitioner shall file fresh I.A. on completion of the civil works at the Grid Sub Station which may take around 15 days. The Learned Advocate further submitted that the prayer for withdrawal of this I.A. with liberty to file a fresh/amended I.A. shall be filed to-day and a copy of the same shall be sent to the respondents (through email and hard copy).

The Learned Counsel for PEDA submitted that 80 panels have been installed in the plant and the petitioner's plant was completed today. However, the Learned Counsel for the petitioner submitted that those were only damaged panels which have been replaced by the petitioner.

The Learned Counsel for the petitioner further submitted that the petitioner shall file a fresh/amended I.A. and serve a copy of the same on the respondents (through email as well as hard copy). In case civil works in the GSS are not completed before the next date of hearing fixed for 15.12.2016, the petitioner shall inform the Commission in advance.

The next date of hearing the petition is fixed for 15.12.2016 at 11:30 A.M.
