## **ORDER**

During hearing, the petitioner submitted a sketch showing the scope of the railway siding work. The Commission raised certain queries and directed that in reply to the said queries, the petitioner would indicate the scope of the railway siding work component wise i.e. Station, Residential Quarters, ROR flyover, incoming & outgoing railway line from the project to SBJ (Sarai Banjara Junction) and emergency cross over etc. and time lines as per the original 2008 Rites Report and revised Rites Report 2015 along with component wise cost bifurcation included in the said Reports. Completion dates of the completed works and details of incomplete works shall also be provided. Any other details as may be required for prudent scrutiny of the original scope of work as envisaged in the 2008 Rites report and 2015 Revised Report be also provided.

The petitioner requested for grant of one month's time for filing details / requisite information. Petitioner shall file the information sought by the Commission with a copy to PSPCL by 26.02.2018. PSPCL may reply to the same with a copy to the petitioner by 26.03.2018 (through e-mail and hard copy).

The petition shall be taken up for hearing on 11.04.2018 at 11.00 A.M.
