**ORDER**

The matter was fixed for arguments on the I.A. No.29 of 2017 as well as the main petition. In compliance of the order dated 18.07.2017, PSPCL vide Memo No.6562 dated 24.07.2017, has submitted its reply to the I.A.No.29 of 2017. During the hearing, the learned counsel for the petitioner has submitted a copy of comparison chart of New and Old Form A&A, which is taken on record. PSPCL may give its clarification regarding the difference between the new A&A Form vis-à-vis the old A&A Form.

The Learned Counsel for the petitioner has argued that vide letter No.999 dated 21.06.2017, the respondents have again raised a fresh / supplementary demand for voltage surcharge for the period from October, 2016 to March, 2017

against the petitioner, directing the petitioner to pay an amount of Rs.15,40,239/- within a period of seven days.

After hearing the Learned Counsel for the petitioner and Officers of PSPCL on the I.A., the supplementary demand raised by PSPCL on 21.06.2017 is stayed till the next date of hearing.
