**ORDER**

The Counsel for the petitioners has submitted that PSPCL has not refunded the amount due, in compliance of the Order dated 18.10.2016 passed by the Commission in Petition No.64 of 2016. It was further contended that PSPCL has submitted before Hon'ble APTEL in the proceedings in Appeal No.06/2017 that PSPCL is implementing the said Order of the

Commission. Also, in reply to the petition, PSPCL has submitted that Commission's Order dated 18.10.2016 has been implemented.

PSPCL is directed to file an affidavit by 01.12.2017 with a copy to the petitioners with regard to detailed information of the bills, amounts refunded to the petitioners, whether full amount refunded or not and reasons for not refunding the amount / part refunding. Further, PSPCL shall also inform the details of interest payable as per the relevant regulations.

Chief Engineer/Commercial, PSPCL shall remain present on the next date of hearing. In case the amounts are not refunded by 01.12.2017, the Commission shall be constrained to impose penalty on PSPCL for not implementing the order of the Commission dated 18.10.2016 and submitting wrong information to Hon'ble APTEL and the Commission.

The petition shall be taken up for hearing on 13.12.2017 at 11.30 A.M.
